WHAT THIS PRIVACY POLICY IS ALL ABOUT

Our goal is to create for you the best user experience on our website. In order to achieve this, when you interact with us through our website, we will gather information on you in order to improve these interactions. Some of this data you will formally give us like your email address; other information may be anonymously gathered.

The below summarises how you may interact with us and how we treat your data. Please take time to understand this as it will affect how your data is managed and what you need to do if you have any questions or make any changes.

COLLECTION AND USE OF PERSONAL INFORMATION

BROWSING OUR WEBSITE

In general, you can browse our website without identifying yourself. We use Google Analytics and Wix visitor analytics to understand our visitors' needs and to continually improve our site for them. We collect only anonymous, aggregate statistics. There are two situations when we collect your personal data. Find them listed below with commentary on how we use it.

Newsletter subscription.

To receive newsletters from us, you need to subscribe to this service by providing us your email. Collected emails are used only by LDN for the initial purpose - sending you a newsletter whenever there is something we want to share with you. We never give your email to a third party. You can always unsubscribe by simply sending us a message stating so.

Booking

During the booking process, we will ask from you additional personal data, such as full name, age, country of residence, phone number etc. We need this information for making your trip happen, for being able to stay in touch with you and personalizing your experience.

We share this information with our partner, Surfcamp 360, as they actively participate in the logistics of the experience and need it to operate.

We don't give these details to any other third party.

LINKS TO OTHER WEBSITES

Our website contains links to information on other websites, for example, instagram. On websites that don't belong to us, we are not responsible for the protection and privacy of any information that you provide while visiting them. They are not governed by this Privacy Policy, and if you have questions about how a site uses your information, you'll need to check that site's privacy statement.
